A good dance program provides students with the opportunity to perform for a live audience. We happily invite all Colorado Dance Center students to participate in our annual Summer Performance. Our performances are a bigger production than a typical recital. Our performances teach dancers the art of story-telling through dance. Each year an original story is written and specific choreography and parts are assigned for each class. The performance stories always include a positive moral. If you cannot participate in the performance, you are still welcome to attend class with us throughout the Summer.

Requirements for participating:

- 1.) Dancers must be enrolled and actively taking class at Colorado Dance Center as of March 1st. (Dancers under age 10 years may be accepted after March 1st based on class size needs, teacher approval, and ability.)
- 2.) Dancer must be up-to-date on monthly tuition.
- 3.) Dancers must pay all performance and costume fees paid in full by March 31st.
- 4.) Dancers must continue to pay normal monthly tuition after performance and costume fees are paid.
- 5.) Dancers can only have 3 absences (three of each class) between May 1st and June 28th. All absences must be approved by the instructor.
- 6.) Dancers cannot miss the mandatory Dress Rehearsal.
- 7.) Dancers must have parent's sign and return all participation forms.

A Message from the Director:

You may be wondering why the location was left off the main information page? Our venue will be announced shortly. We have secured a wonderful high school theater but are still waiting to hear from our familiar Lone Tree Arts Center facility. We know that our dance family has performed with the LTAC for several years and we are very comfortable with that partnership and familiarity. However they have made changes to their rental policy and have increased pricing. We too have made some changes with our performance being in June instead of July. With the performance around the corner in a few short months, I do not want to delay our production or interfere with your summer planning. Costumes need to be ordered and can take up to 8 weeks for arrival after production. Regardless of which venue we dance at, we want to keep the same dates.

Please note the venue will be a determining factor in ticket prices. (Hopefully \$15 or less) Colorado Dance Center will continue to strive to keep our ticket prices as reasonable as possible for families. We are honored to be a second generation studio that has proudly served the community for over 35 years.

We hope this information packet will help you with your summer plans. Thank you for your patience regarding this detail. Each dancer is a treasured gift to our studio family and we thank you for choosing Colorado Dance Center. Please let me know if you have any questions regarding the upcoming performance.

Performance choreography is taught during normal classes. After the performance the studio will be closed the month of July and then re-open in August. Nutcracker Auditions will be end of August.

\$130 Performance Fee

(\$65 for second additional dancer, \$25 for third additional dancer, \$10 for fourth additional dancer).

*Performance fees cover many production costs including theater & dressing room rentals, stage & production management, staffing, security, music licensing, backdrops, props, program printing costs- all accumulated for expenses covering three days total (one dress rehearsal and two performances).

Performance fees are Non-Refundable.

Costume Fees

(Dancers get to keep all purchased costumes. Borrowed costumes must be returned). Ballet dancers who meet twice a week will only have to purchase one costume & the second costume is borrowed from the studio.) Students are measured in class by an instructor for purchased costumes. Please contact us if you want to measure your own child and send measurements. Costumes can take 6-8 weeks to arrive once our order is received and production takes place.

Costume fees are Non-refundable.
